

WAIVERS FOR: Beacon Day Camp 2019 and Crossover 2019

Health & Medical Waiver The camper/student's parent/legal guardian warrants that the camper/student is physically fit and able to participate in all activities, and consents to any employee, agent, volunteer, or other personnel affiliated with Beacon Day Camp or Crossover 2019, to seek medical attention and treatment or other measures deemed necessary or advisable in the discretion or judgment of Beacon Day Camp or Crossover 2019 Personnel for the child/student in the event of an accident, sudden illness, or other condition that occurs while the camper/student is in the care or under the supervision of Beacon Day Camp or Crossover 2019 Personnel.

The parent/legal guardian further understands that Beacon Day Camp or Crossover 2019 Personnel will make reasonable efforts to notify the parent/legal guardian or another parent of the camper/student in the case of an accident, sudden illness or other condition, but authorizes Beacon Day Camp or Crossover 2019 Personnel to seek such care or treatment, and for any care or treatment to be administered, even in the event that either parent or legal guardian are not contacted prior to the seeking or rendering of such care, treatment, or other measures.

The parent/legal guardian releases Beacon Evangelical Free Church, Township of Galloway, and other possible off-property locations such as Galloway Swim Club, Patriots Lake, in addition to all Beacon Day Camp or Crossover 2019 Personnel, from and of any liability for such decisions or actions in seeking medical care, and agrees to pay all the costs and fees for the medical care or treatment authorized under this Emergency Medical Authorization.

Liability Waiver The parent/legal guardian agrees to hold harmless Beacon Evangelical Free Church, Township of Galloway, other possible off-property locations such as Galloway Swim Club, Patriots Lake, and all Beacon Day Camp or Crossover 2019 Personnel, and the owners of any properties in Beacon Day Camp or Crossover 2019 made available for camp activities, from any claims, damages, losses and/or expenses arising out of participation in activities and to assume all liability for any and all personal injury, bodily injury, illness or property damage that occurs as a result of participation in such activities. The parent/legal guardian also warrants that participation in Beacon Day Camp or Crossover 2019 is voluntary and that the camper/student and the parent/legal guardian understand the inherent risks involved in activities, and the camper/student agrees to obey all rules and policies mandated by personnel. I also understand that if camper/students have activities where transportation is needed, it will be provided through a Beacon Evangelical Free Church 15-passenger van, driven by a certified driver.

Photo/Video Release The parent/legal guardian grants Beacon Evangelical Free Church and Beacon Day Camp and Crossover 2019 Personnel the right to photograph my dependent and use the photo and/or other digital reproduction of him/her or other reproduction of his/her physical likeness for publication processes, whether electronic, print, digital or electronic publishing via the internet.
